Duties:

This position(s) will require someone with strong communication and coordination skills who is able to multitask and solve problems while thinking quickly but keeping calm during a high-tempo day. This position will include being both a Program officer for one or more Sea Grant programs, as well as manage a topical area (ie. extension or interdisciplinary work). The individual selected will:

- Coordinate and administer one or more National Sea Grant College Program portfolios and/or activities to achieve effective operations.
- Analyze National Sea Grant College Program requirements, policies, regulations, and guidelines in order to provide effective and efficient information, interpretation, recommendations, and implementation.
- Serve as a liaison between the federal government, universities, and partners for an
 assigned portfolio which could include topical or programmatic partnership
 development and implementation. This may include interacting with internal and
 external partners to anticipate and share emerging needs and updates from a network
 or working group to a higher-level position.

Specific duties will include:

- Engage with agency and administration leadership and staff.
- Identify and support partnerships related to Sea Grant priorities.
- Develop funding opportunities and other program requirements.
- Carry out proposal reviews, process grant actions and provide oversight of active grant awards.
- Organize and support meetings with grant recipients, which may include annual gatherings.

SUBSTITUTION OF EDUCATION: Ph.D. or equivalent doctoral degree or 3 full years of progressively higher level graduate education leading to such a degree or LL.M., if related.

OR

COMBINATION OF EDUCATION AND EXPERIENCE: A combination of education and experience as described above.

NOTE: Only graduate education in excess of two years is qualifying for combination.
