Policies and Procedures

Each year the University of South Alabama Alumni Association honors faculty for high achievements in the realm of research as appropriate to his/her discipline.

Award Name: Olivia Rambo McGlothren National Alumni Association
Outstanding Scholar Award

Award: Recipient will be presented a cash award and plaque
by the Alumni Association at its Annual Meeting in
August/September 2025.

ELIGIBILITY

The award is open to any full-time instructional faculty member with at least three years of experience at the University of South Alabama. No college/school or departmental quotas shall exist regarding the number of nominations submitted. Recipients are not eligible for nomination for three consecutive years following the award. Thereafter, they are eligible.

NOMINATING PROCEDURES

- ♦ The Dean of each College/School is asked to submit a nomination packet to the Office of Alumni Relations.

These materials are due June 30, 2025:

1. A letter from the nominator including rationale for the nomination and any information you want the selection committee to know;
2. The nominee's CV and any supporting materials.

TIME LINE

Deadline for receipt of nominations: June 30, 2025

Presentation of Award at Alumni Association Annual Meeting: August/September 2025

CALL FOR NOMINATIONS

The call for nominations will be announced via e-mail to all Deans.

SELECTION PROCEDURE

A committee chaired by the Provost, Senior Vice President of Academic Affairs and consisting of the following representatives will select the recipient.

- ◆ Provost, Senior Vice President of Academic Affairs
- ◆ President of the National Alumni Association or designee
- ◆ Vice President of the National Alumni Association
- ◆ President of the Student Government Association
- ◆ President of the Southerners
- ◆ Two faculty members appointed by the Senior Vice President for Academic Affairs

Nominations form must be received no later than June 30, 2025. Late nominations will not be considered. Items below are due June 30, 2025:

1. A letter from the nominator including rationale for the nomination and any information you want the selection committee to know;
2. The nominee's CV and any supporting materials.
